Other tests can carried out for a fee at our going rate of \$120.00 per hour.

Samples should be delivered at the lab Mondays through Fridays, between the hours of 8 a.m. to 4 p.m. Water samples are not accepted on Fridays and food/feed samples for bacterial testing may not be started if results would be expected during the weekend. Samples delivered to the laboratory requiring weekend work and "rushed samples" will be subject to higher fees.
